ARMAS, DANIA DDS 49454

Effective 6-14-09
Decision following administrative hearing. Petition granted for early termination of probation.

CABRERA, ALBERT DDS 39517

Effective 5-13-09
Default revocation following an accusation based upon a substantially related criminal conviction.

CORDOVA, LETITIA Y.

RDA Applicant

Effective 5-13-09
Decision following administrative hearing. Three-year probationary license will be issued upon completion of exam and all other licensing requirements. Decision based upon convictions and making a false statement on application.

FAYNGOR, IRINA

Effective 5-22-09
Decision following administrative hearing; petition for reinstatement of revoked dental license denied.

FOSS, TAYLOR ANN RDA 68238

Effective 5-22-09
Stipulated settlement with admissions. Revocation stayed with 5 years' probation based upon allegations of fraudulently obtaining unauthorized prescriptions and practicing with an expired license.

Effective 6-14-09
Decision following administrative hearing; application denied.

GIVENS, VICKI RDA 46822

Effective 5-13-09
Decision pursuant to stipulated settlement. Petition for reinstatement of revoked license granted and license is reinstated. However, the Order requires license be revoked, revocation is stayed and license is placed on 5 years' probation.

HENDERSON, LISA MARIE

RDA 71523

Effective 6-14-09
Default revocation following accusation for failing to comply with previous Board Order.

JONES, BRADLEY C. DDS 37678

Effective 5-13-09
Decision following administrative hearing. Revocation stayed with 5 years' probation (first 12 months in actual suspension) based upon violating state drug statutes (obtained and possessed controlled substances without a valid prescription, administered to himself a controlled substance without a valid prescription, used controlled substances in a manner dangerous to himself or others) and failing to fully comply with previous Board Order.

LAYUS, CLAYTON A. DDS 29339

Effective 5-22-09
Stipulated that board allegations constitute cause for discipline. Revocation stayed with 5 years' probation based upon treatment allegations.

MESBAH, RAHIM DDS 48961

Effective 3-23-09
Decision following administrative

hearing. Petition for early termination of probation denied; petition for modification of probationary Order granted (elimination of supervision requirement).

NGUYEN, BETTY NHU Y

RDA 73901

Effective 5-22-09
Stipulated settlement with admissions. Revocation stayed with 1 year probation based on the commission of acts constituting grounds for suspension or revocation of a license.

O'BRYAN, ROBERT PATRICK

DDS 50710

Effective 5-13-09
Default revocation following an Accusation based upon allegations of obtaining controlled substances by fraud, fraudulent prescription writing, and failure to maintain records of dangerous drugs.

PARK, SANG-HYUK DDS 47654

Effective 5-27-09
Stipulated that if proven at hearing, allegations constitute cause for discipline. Revocation stayed with 3 years' probation based upon treatment and insurance fraud allegations.

PIKE, SABRINA PAULETTE

RDA 70880

a.k.a. Sabrina Sawacki

a.k.a. Sabrina Stowers

Effective 6-14-09
Default revocation following an Accusation based upon allegations of unlawful procurement and furnishing of controlled substances and dangerous drugs and dishonest

conduct.

**RAFIEYAN, NAZAFANIN
DDS 50984**

Effective 5-27-09
Stipulated that if proven at hearing, allegations constitute cause for discipline. Revocation stayed with 3 years' probation based upon treatment allegations.

**ROGERS, DAVID EUGENE
DDS 46425**

Effective 5-27-09
Stipulated, without admitting the allegations, that at a hearing, the Board could establish a prima facie factual basis for the causes for discipline in the Accusation. Revocation stayed with 3 years' probation based upon allegations of improper prescribing of drugs, insurance fraud, and unlawful practice of medicine.

**ROMAYOR, ANGELA MARIE
RDA Applicant**

Effective 5-22-09
Decision following administrative hearing; application denied.

SANDOVAL, EDGAR RDA 66579

Effective 5-27-09
Stipulated settlement with admissions. Revocation stayed with 3 years' probation based upon a substantially related criminal conviction.

**SCHUTT, KYRIE RDA 66895
a.k.a. Kyrie Parker**

Effective 5-13-09
Stipulated surrender of license with admissions based upon a substantially related criminal conviction.

SHIN, WOO CHUN DDS 28090

Effective 5-13-09
Stipulated that if proven at hearing, charges and allegations constitute cause for imposing discipline. Revocation stayed with 5 years' probation based upon treatment allegations.

**SMITH, AMANDA DAWN
RDA 61468**

Effective 5-22-09
Default revocation following an Accusation based upon a substantially related criminal conviction.

**STROSCHEIN, GUILBERT T.
DDS 17779, GA 535**

Effective 5-13-09
Stipulated surrender of license and anesthesia permit. While making no personal admissions, and for the purposes of resolving the Accusation, stipulated that the Board could establish a prima facie factual basis for each of the charges and that those charges constitute cause for discipline. Accusation was based upon aiding and abetting unlicensed person and gross negligence (patient death).

TATUM, SHONTAY M. RDA 73974

Effective 5-13-09
Stipulated settlement with admissions. Revocation stayed with 5 years' probation based upon a substantially related criminal conviction.

**VISOUTSRI, MANGKONE
RDA 73905**

Effective 5-22-09
Stipulated settlement with admissions. Revocation stayed with 5 years' probation based upon convictions and making a false statement on application.

**WARD, DOUGLAS AUSTIN G.
Effective 5-22-09**

Decision after administrative hearing; petition for reinstatement of surrendered dental license denied.

**WATTS, CASSANDRA PAULETTE
RDA 56809**

Effective 5-10-09
Default revocation following an Accusation based upon violation of state drug statutes involving possession and use of a dangerous

drug.

**ZIEGLER, ABBY JO DDS 34921
a.k.a. Abby Jo Cruz**

Effective 5-13-09
Default revocation following an Accusation based upon a substantially related criminal conviction.

Decisions become operative on the effective date, except in situations when the licensee obtains a court-ordered stay. This may occur after the publication of the administrative action in the Hot Sheet. Stay orders do not occur in stipulated decisions, which are negotiated settlements waiving court appeals.
