THE HOT SHEET – A SUMMARY OF ADMINISTRATIVE ACTIONS

July - September 2009

A summary of administrative matters for the Dental Board of California:

AL-FARAJE, LOUAI

DDS 42265

Effective 7-24-09

Stipulated that if proven at a hearing, the Board's allegations would constitute cause for discipline. Public reprimand with conditions, based upon treatment allegations involving one patient.

ARROYO, BERTHA S.

RDA 54530

Effective 8-27-09

Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon a conviction for a crime substantially related to the qualifications, functions or duties of an auxiliary.

BOSSETT, CHARLES EDWARD

DDS 36891

Effective 9-27-09

Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon employing and utilizing an RDA to perform duties requiring an RDH or dental license.

CARLSON, JANE ANN

RDA 74270

a.k.a. Jane Ann Vavrina

Effective 7-30-09

Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon criminal convictions and dishonest acts substantially related to the qualifications, functions, or duties

of an auxiliary, and making a false statement on her application.

CHEN, CHIUN-HUNG

DDS 50734

Effective 7-5-09

Stipulated that at a hearing, if proven, the allegations constitute cause for imposing discipline. Revocation stayed with 3 years' probation with terms and conditions, based upon treatment allegations.

ENDFINGER, JATTIE E.

RDA 56018

Effective 7-3-09

Default revocation when there was no response to the Board's Accusation. The Accusation is based upon criminal convictions substantially related to the qualifications, functions, or duties of an auxiliary.

ERFANI, SHERVIN

DDS 42465

Effective 7-30-09

Stipulated that if proven at hearing, some allegations constitute cause for discipline. Voluntary surrender of license based upon treatment allegations.

FERRIS, DEBORAH LYNN

RDA 62229

Effective 7-23-09

Stipulated settlement with admissions. Revocation stayed with 2 years' probation with terms and conditions, based on violations of state drug statutes (being under the influence of a controlled substance without a prescription and in possession of drug paraphernalia).

FINLEY, SHALAYA

RDA 74371

Effective 9-30-09

Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon criminal convictions substantially related to the qualifications, functions or duties of an auxiliary.

GIBSON, TAMRA D.

RDA 74350

Effective 8-27-09

Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based on out-of-state criminal conviction (driving while intoxicated) and making a false statement on her application for a license by failing to disclose the conviction.

GOUGALOFF, ROBERT

Effective 8-15-09

Decision following administrative hearing; petition for reinstatement of revoked dental license denied.

GRANADOS, LIDA MARIE

RDA 65126

Effective 9-30-09

Stipulated settlement with admissions. Revocation stayed with 2 years' probation with terms and conditions, based upon a criminal conviction substantially related to the qualifications, functions or duties of an auxiliary.

GRANDHI, RAM KUMAR

DDS 53426

Effective 7-24-09

Decision following administrative hearing; revocation based upon findings of unprofessional conduct (patient abandonment).

GRANT, LEON, DDS 37226
Effective 7-30-09
Default revocation when there was no response to the Board's Accusation. The Accusation is based on failure to comply fully with conditions of probation in a previous Board Order.

HASHEMI, SHAHRYAR DDS 50606
Effective 7-24-09
Stipulated that some of the board's allegations, if proven at a hearing, constitute cause for discipline. Allegation of gross negligence was denied. Revocation stayed with 2 years' probation with terms and conditions, based upon treatment allegations.

HENNING, SCOTT CARL DDS 36083
Effective 8-27-09
Stipulated settlement with admissions. Stipulated to the revocation of the license based upon a conviction substantially related to the qualifications, functions or duties of a dentist.

JIMENEZ, JANET a.k.a. Janet J. Trujillo RDA Applicant
Effective 7-8-09
Decision following administrative hearing; application denied.

KERN, SHAWNA MICHELLE Prev. Shawna Michelle Keefe RDA 74267
Effective 8-27-09
Decision following administrative hearing. Two-year probationary license with terms and conditions issued, based upon criminal convictions substantially related to the qualifications, functions, or duties of an auxiliary.

KNIGHT, ASHLEY OLIVIA

RDA 74383
Effective 9-30-09
Stipulated settlement with admissions. Revocation stayed with 2 years' probation with terms and conditions, based upon criminal convictions substantially related to the qualifications, functions, or duties of an auxiliary and making a false statement on the license application by failing to disclose the convictions.

LARSEN, ANGELA MARIA RDA 55095
Effective 9-25-09
Default revocation when there was no response to the Board's Accusation. The Accusation is based upon failure to fully comply with conditions of a previous Board Order.

LEUNG, TANIA DDS 53625
Effective 7-24-09
Stipulated settlement with admissions. Revocation stayed with 5 years probation with terms and conditions which include 15 days actual suspension, based upon treatment allegations.

LOPES, JEFFREY C. DDS 29809
Effective 7-23-09
Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon employing and utilizing an unlicensed dental hygienist.

MATA, SOPHIA MARIZA RDA Applicant
Effective 9-25-09
Decision following administrative hearing; application denied.

MENDOZA, ALEJANDRA RDA 75514
Effective 9-25-09
Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon criminal convictions substantially

related to the qualifications, functions, or duties of an auxiliary.

MORALES-COMPARINI, LILIAN RDA 45761
Effective 09-25-09
Default revocation when there was no response to the Board's Accusation. The Accusation is based upon criminal convictions substantially related to the qualifications, functions, or duties of an auxiliary, and upon providing false information to the board to obtain her license.

NOOR, ASMATH S. DDS 43307
Effective 7-30-09
Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon treatment allegations.

OKEMWA, JUANITA R. DDS 51689
Effective 7-30-09
Voluntary surrender of license in accordance with terms of a previous Board Order.

OVERLEY, BRYN RDA 54223
Effective 7-5-09
Stipulated settlement with admissions. Revocation stayed with 2 years' probation with terms and conditions, based upon practice with an expired license and failure to comply fully with terms of a previous Board Order.

REYES, CHRISTINA BIANCA a.k.a. Christina Bianca Austi RDA 56044
Effective 8-27-09
Default revocation when there was no response to the Board's Accusation. The Accusation is based upon a criminal conviction substantially related to the qualifications, functions, or duties of an auxiliary.
SEBASTIAN, RONALD DDS Applicant
Effective 8-13-09
Application denied by default.

SNYDER, JOANIE MARIE
RDA 39641

Effective 09-27-09

Stipulated settlement with admissions. Stipulated to the surrender of her license based upon criminal convictions substantially related to the qualifications, functions, or duties of an auxiliary.

SOLAK, LEVON DDS 44542

Effective 9-25-09

Decision following administrative hearing. Revocation based upon a criminal conviction substantially related to the qualifications, functions, or duties of a dentist, and upon unprofessional conduct for employing or making use of a solicitor.

TANI, STUART TERUO

DDS 32622

Effective 8-27-09

Stipulated that at a hearing, the Board could establish a factual basis for the charges of repeated acts of negligence as set forth in the First Amended Accusation, and if proven at a hearing, the charges and allegations would constitute cause for imposing discipline upon his license. Revocation stayed with 3 years' probation with terms and conditions, based upon alleged gross negligence and/or repeated acts of negligence in treating one patient.

THIBODEAUX, DARTWAUN T.

RDA 62741

Effective 8-13-09

Default revocation when there was no response to the Board's Accusation. The Accusation is based on a criminal conviction substantially related to the qualifications, functions, or duties of an auxiliary.

RDA Applicant

Effective 9-25-09

Decision following administrating

hearing; application denied.

THOMASSEN, JOHN ARTHUR

Effective 8-15-09

Decision following administrative hearing; petition for reinstatement of revoked dental license denied.

TSUEI, MARK

DDS 35794

Effective 8-27-09

Decision following administrative hearing. Revocation stayed with 3 years' probation with terms and conditions, based upon criminal convictions substantially related to the qualifications, functions, or duties of a dentist.

WAGGERMAN, EVE A.

RDA 64723

Effective 8-13-09

Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon a criminal conviction substantially related to the qualifications, functions, or duties of an auxiliary.

WANG, SHIYU DDS 50693

Effective 7-8-09

Decision following administrative hearing; revocation stayed with 3 years' probation with terms and conditions, based upon findings of gross negligence, incompetence, and excessive treatment in treating two patients.

YOO, DONG JUN

DDS 47023

Effective 9-27-09

Stipulated settlement with admissions. Revocation stayed with 3 years' probation with terms and conditions, based upon a criminal conviction substantially related to the qualifications, functions, or duties of a dentist.

ZBROJIK, SERGEI M.

DDS 48416

Effective 9-25-09

Decision following administrative hearing. Reprimand based upon failure to report the death of a patient within the time required by

law.

These administrative actions were taken by the Board from July 1 – September 30, 2009. The decisions become operative on the effective date, except in situations where the licensee obtains a court ordered stay. This may occur after the publication of the administrative action in the Hot Sheet. Stay orders do not occur in stipulated decisions, which are negotiated settlements waiving court appeals.
