This page and pages that may follow, display an alphabetical listing of actions taken by the Board during the specified period. To verify the license or permit of any one of the board's licensees, and view disciplinary documents if applicable, the following steps may be helpful.

1. From the homepage, [www.dbc.ca.gov](http://www.dbc.ca.gov), select "License Verification" from the subject tabs displayed across the top of the page.
2. Select "License Verification" (again), and you will be on the homepage for the new State of California's BreEze System.
3. Select "Verify a License".
4. Select "Search by License Number".
5. On the "Search by License Number" page:
  - a. Select "Dental Board of California" from the Board drop-down menu.
  - b. Select the license (or permit) **type** from the drop-down menu.
  - c. Enter the license (or permit) number – numerals only.
6. Click the "Search" option on the right side of your screen. (Hitting 'enter' won't work!)
7. The name that comes up should be the name associated with the license number on this page. Click on the name and you will see information on the status of the license. Scroll down to see discipline documents (identified with an "ENF" reference), that you can open to read or print.
