## Agenda Item 1: Call to Order/Roll Call/Establishment of a Quorum

Council Vice Chair, Ms. Jeri Fowler, called the meeting to order at 9:06 a.m.; five members of the Council were present, and a quorum was established.

#### Agenda Item 2: Public Comment on Items Not on the Agenda

There were no public comments made on this item.

Agenda Item 3: Discussion and Possible Action on August 19, 2021 Meeting Minutes Motion/Second/Call the Question (M/S/C) (Miyasaki/Reed-Espinoza) to approve the August 19, 2021 Meeting Minutes.

Ayes: Fowler, Miyasaki, Olague, Pacheco, Reed-Espinoza.

The motion passed and the minutes were approved. There were no public comments made on this item.

# Agenda Item 4: Update on Dental Assisting Educational Program and Course Applications and Re-Evaluations

Ms. Tina Vallery, Chief of Licensing and Administration, provided the report, which is available in the meeting materials. A re-evaluation update will be provided at the next Council meeting in 2022.

There were no public comments made on this item.

## Agenda Item 5: Update Regarding Council Member Vacancies and Recruitment

Ms. Karen Fischer, Executive Officer, provided the report, which is available in the meeting materials. Since the last Council meeting, two members, Ms. Melinda Cazares and Ms. Michele Jawad, resigned from the Council. Both members had other obligations that did not allow them to be able to participate in these meetings. The Board posted a recruitment on its website, and the stakeholder associations have put forth word that the Council is recutting for two registered dental assistants (RDA) employed clinically in a private dental practice or public safety net or dental health care clinic. In the event that the subcommittee of Ms. Olague and Ms. Pacheco are unable to find suitable candidates to bring before the Board at the February meeting, the Board will keep the recruitment notice open as a continuous recruitment until those two positions can be filled.

There were no public comments made on this item.

### Agenda Item 6: Update on Dental Assisting Examination Statistics

Ms. Vallery provided the report, which is available in the meeting materials. Data for fiscal year (FY) 2021/2022 in relation to the Orthodontic Assistant (OA) Permit written examination is reported incorrectly in the memorandum. As mentioned at the previous Board meeting, the DCA Office of Professional Examination Services (OPES) conducted an occupational analysis of OA practice, which resulted in an update being made to the OA Permit written examination. On September 1, 2021, the OA Permit written examination was modified to adjust the examination content. During the initial release of a new examination, exam scores are held pending evaluation and validation of the preliminary passing scores established. The OA permit written exam scores were released in late October and may not be reflected accurately in this present memorandum as it was prepared prior to the release of scores. Updated information will be provided at the next Council meeting.

Council Member, Ms. Cara Miyasaki, mentioned that goal 1.3 of the Board's Strategic Plan states that there is a workforce shortage among dental assistants. She believes the

low licensure pass rate for the Registered Dental Assistant (RDA) written exam could be contributing to the shortage. Regarding goal 1.4 of the Strategic Plan, she asked whether it needs to be addressed by the Council before it is addressed by the Board. Since the Strategic Plan was not agendized on the Council's agenda, Ms. Fischer replied that Board staff would take note of Ms. Miyasaki's comments and follow up. Vice Chair Fowler thanked Ms. Vallery for pointing out the OA permit information as being incorrect and looked forward to the 2022 meeting when the Council could discuss the statistics further.

There were no public comments made on this item.

<u>Agenda Item 7: Update on Dental Assisting Licensing Statistics</u>

Ms. Vallery provided the report, which is available in the meeting materials.

The Council received public comment. Claudia Pohl pointed out that the "License Type" for Dental Sedation Assistant (DSA) on page 21 of the meeting materials showed that for FY 2018/2019, there were 1,167 active DSAs, followed by 36, 38, and 38 for the following years. Ms. Pohl questioned whether the statistics were accurate and if they were not, she requested that the Council provide updated statistics on the numbers.

# <u>Agenda Item 8: Presentation by Department of Consumer Affairs, Office of Professional</u> Examination Services (OPES) Regarding RDAEF Occupational Analysis

Ms. Karen Okicich, M.A., Research Data Supervisor II, from OPES, provided an overview of the RDAEF Occupational Analysis report, which is available in the meeting materials. In California, licensing boards are required to adhere to Business and Professions Code (BPC) Section 139. Ms. Okicich provided an overview of the factors that go into establishing validity and the cycle of examination development. She noted that the occupational analysis is an important and foundational part of examination development and provided an in-depth description of the process. Based on the results of the occupational analysis in conjunction with other analyses that OPES has performed regarding incorporating information from the clinical and practical exams into the written examination, OPES made two recommendations to the Board. The first recommendation was to adjust the content of the written examination by increasing the number of items in order to be able to assess those competencies from the written and practical examinations. The second recommendation that was provided was to increase the time that candidates are allowed to take the exam.

There were no public comments made on this item.

# <u>Agenda Item 9: Update Regarding RDAEF Licensure Requirements and Administration of New RDAEF Written Examination</u>

Ms. Sarah Wallace, Assistant Executive Officer, provided the report, which is available in the meeting materials. There were no public comments made on this item.

Agenda Item 10: Discussion and Possible Action Regarding Legislative Proposal to Amend Business and Professions Code Sections 1750.2, 1750.4, and 1752.1 to Specify

<u>Time Limits for Acceptance of Course Certifications for OA Permit and DSA Permit Applications and Clarify Board-Approved Course Requirements for RDA Applicants</u>

Ms. Wallace provided the report, which is available in the meeting materials. Board staff suggested the Council consider whether a recommendation should be forwarded to the Board to amend BPC sections 1750.2, 1750.4, and 1752.1 to specify a time frame within which these courses should be successfully completed prior to applying to the Board for an OA or DSA permit. Additionally, the Council may wish to consider whether BPC section 1752.1 should be amended to specify that it is a two-hour course in the DPA and an eighthour course in infection control that is required for licensure as an RDA. Ms. Wallace verbalized that if the Council wished to move forward with this recommendation, Board staff recommended that it be forwarded to the Board as a legislative proposal to be included as a new issue in the Board's Sunset Review Report, which is expected to be submitted next year. Ms. Welch clarified to Ms. Fowler that the motion should recommend to the Board a legislative proposal to amend BPC sections 1750.2, 1750.4, and 1752.1 to clarify the RDA, OA, and DSA course completion requirements for license and permit application.

(M/S/C) (Fowler/Miyasaki) to move to recommend to the Board a legislative proposal to amend BPC sections 1750.2, 1750.4, and 1752.1 to clarify the RDA, OA, and DSA course completion requirements for license and permit application.

The motion passed. The Council received public comment. Claudia Pohl, representing California Dental Assistants Association (CDAA), thanked Board staff for bringing this issue forward. On behalf of the CDAA, she noted that they are in favor of this proposal.

Agenda Item 11: Discussion and Possible Action Regarding RDAEF Administration of Local Anesthesia and Nitrous Oxide

Ms. Wallace provided the report, which is available in the meeting materials.

Vice Chair Fowler proposed that the Council form a two-member committee to create relevant survey questions. She indicated that there are questions regarding procedure efficiency that need to be addressed that relate to the administration of local anesthesia. Vice Chair Fowler stated this issue is a very worthy topic that the Council needs to discuss further. She voiced that she would like to be a member of the committee. Council Member, Ms. Traci Reed-Espinoza, agreed with Vice Chair Fowler's comments and requested to put her name on the committee.

(M/S/C) (Fowler/Reed-Espinoza) for Vice Chair Fowler and Ms. Reed-Espinoza to establish a two-member working group to discuss the specific issues to be studied,

create relevant survey questions, and return to the Council with a list of the specific issues to be studied and survey questions.

The motion passed. There were no public comments made on this item.

# <u>Agenda Item 12: Discussion and Possible Action Regarding Administration of Written Examinations in Different Languages</u>

Ms. Wallace and Dr. Tracy Montez, Ph.D., Division Chief of Programs and Policy Review for DCA, provided the report, which is available in the meeting materials. Dr. Montez explained that to adapt a licensing exam into a language other than English, OPES takes an examination that is in English and brings in subject matter experts (SMEs), who are licensees, active and in good standing in the respected profession, to go through the exam items individually and translate them to the best of their ability in the desired language. Afterwards, the exam is translated back into English with another set of SMEs to determine whether the true intent of the question was captured. Dr. Montez communicated that it is extremely costly to bring in SMEs to examine or translate exam forms each time they are rotated. This results in an important consideration when faced with the decision of whether to adapt an examination.

Ms. Miyasaki thanked Dr. Montez for the presentation and inquired how other languages for the Board of Barbering and Cosmetology (BBC), such as Vietnamese and Korean, are doing, if there are statistics for those languages, and if the pass rates are comparable. Dr. Montez suggested that this information can be found on the BBC website. Dr. Montez replied that the BBC exams appear to be reasonable as they have not been a concern to the BBC; the BBC has been really focused on Spanish. At the moment, the BBC uses a national vendor to develop their exams.

There were no public comments made on this item.

### Agenda Item 13: Election of 2022 Council Chair and Vice Chair

Ms. Fischer facilitated the election. She opened the floor for nominations for the position of Chair.

Ms. Olague nominated Vice Chair Fowler. Vice Chair Fowler accepted the nomination. There were no additional nominations.

## Background:

### **Update Regarding RDAEF Licensure Requirements:**

Senate Bill (SB) 607 (Min, Chapter 367, Statutes of 2021) was signed by Governor Newsom on September 28, 2021, and became effective on January 1, 2022. Among other things, this bill removed the clinical and/or practical examination requirements to become a California Registered Dental Assistant in Extended Functions (RDAEF).

Effective January 1, 2022, the Dental Board of California (Board) may license as an RDAEF a person who submits written evidence, satisfactory to the Board, of all the following eligibility requirements:

- 1. Current licensure as a Registered Dental Assistant (RDA) or completion of the requirements for licensure as a RDA;
- Successful completion of a Board-approved course in the application of Pit & Fissure Sealants:
- 3. Successful completion of a Board-approved RDAEF program;
- 4. Successful passage of a written examination administered by the Board; and
- 5. Submission of fingerprint clearances from both the Department of Justice and the Federal Bureau of Investigation.

The Board worked with the Department of Consumer Affairs' Office of Professional Examination Services (OPES) to conduct an occupational analysis of the RDAEF profession. Based on the results of the occupational analysis, a new RDAEF written examination was launched on January 1, 2022. This examination incorporates additional content that measures competencies related to cord retraction and final impression, which were previously measured by the practical and clinical examinations. RDAEF applicants who had already taken and passed the previous RDAEF written examination were not required to take the new exam.

Agenda Item 6: Update Regarding RDAEF Licensure Requirements and Administration of New RDAEF Written Examination Dental Assisting Council Meeting January 28, 2022

For those who had an application on file with the Board for RDAEF licensure, the Board:

- Issued refunds for the practical and clinical examination fees (\$500) to applicants who paid the fee and did not take the examination(s). Refunds were processed in mid-October 2021 and applicants should have already received refunds.
- 2. Issued 253 licenses to RDAEF applicants who successfully met all licensure requirements in effect as of January 1, 2022.

#### Administration of New RDAEF Written Examination

Beginning January 1, 2022, all applicants for RDAEF licensure are required to take the new RDEAF Written Examination. Based in the findings of the occupational analysis, OPES developed an examination outline that is structured into four content areas weighted relative to the other content areas. The new outline identifies the tasks and knowledge critical to safe and competent RDAEF practice in California at the time of license issuance. The examination outline has been posted on the Board's website.

Please note, examinee scores for the new RDAEF written examination will be held pending evaluation of examination performance. The Board anticipates having the results released by mid-February 2022 and will be able to issue licenses to those candidates who successfully pass the written examination.

### **Program and Course Re-Evaluations**

The Dental Board of California (Board) has the authority to re-evaluate RDA and RDAEF programs and dental assisting educational courses to ensure compliance with regulations in the event the Board deems it necessary. Pursuant to California Code of Regulations (CCR), title 16, section 1070, subsection (a)(2), all RDA and RDAEF programs and dental assisting educational courses shall be re-evaluated approximately every seven years but may be subject to re-evaluation and inspection by the Board at any time to review and investigate compliance with the Dental Practice Act.

The re-evaluation process is a review of currently approved programs and courses. The goal of the re-evaluation is to ensure that the programs and courses are in compliance with current laws and regulations. During the re-evaluations, the approved programs and courses can continue to offer and provide their programs and courses.

When a program or course has been identified by Board staff for re-evaluation, a notice of the re-evaluation is sent to the program or course, and they are given approximately one month to submit the required documentation to the Board. Once the documentation has been received by the Board, the information is reviewed by a Board Subject Matter Expert (SME). After the review is completed, the program or course is notified of their

continuance of Board approval or any deficiencies identified by the SME. If deficiencies have been identified, the program or course will be notified of the deficiencies and given 30 days to submit correction documents to the Board. If no response is received by the program/course, either to the initial notice of re-evaluation or the deficiency notice within the specified timeframe, a notice will be sent to the program/course notifying them of the withdrawal of Board approval. The withdrawal of Board approval will become effective 90 days from the date of the notice.

### Background

At its November 2018 meeting, the Council heard a presentation from Joan Greenfield, RDAEF, MS, regarding a proposal to add the administration of local anesthesia and nitrous oxide to the scope of practice of registered dental assistants in extended functions (RDAEFs) licensed on or after January 1, 2010, as an optional post-licensure permit with conditions determined by the Board. During this meeting, the Council discussed the necessity of adding the administration of local anesthesia and nitrous oxide to the scope of practice for RDAEFs and expressed concern for public protection.

The Council directed staff to conduct more in-depth surveys of both dentists and a larger sample of RDAEFs to assess their opinions on adding the administration of local anesthesia and nitrous oxide to the RDAEF scope of practice. In addition, the Council directed the formation of a working group consisting of dentists, hygienists, RDAEFs, and other interested stakeholders to research and evaluate the proposal, and recommended the Board consider exploring the possibility of eliminating the multiple layers of RDAEF certifications by incorporating all of them under one general RDAEF license.

At its August 2021 meeting, staff advised the Board that it does not have sufficient staff resources to carry out the Council's direction regarding the development of a survey and the formation of a working group. Board staff determined that to move forward with the Council's request, a Board member would be needed to assist staff with the surveys and working groups. The Board members held a robust discussion of the issues, and the Board considered whether to move forward with developing a survey and forming a Board member and staff working group to study the need for expanding the RDAEF scope of practice to allow administration of local anesthesia and nitrous oxide. Board members expressed concern that it was unclear as to what the Council wanted to be studied. Some Board members favored moving forward with the Council's recommendation but would need additional information from the Council. A motion failed that would have moved forward with the Council's recommendation to conduct more in-depth surveys of both

dentists and a larger sample of RDAEFs to assess their opinions on adding the administration of local anesthesia and nitrous oxide to the RDAEF scope of practice.

At its November 2021 meeting, the Council was asked to reevaluate whether a survey and study of these issues needed to be performed, and if so, the Council was asked to define the specific issues to be studied and surveyed, with a list of pertinent survey questions, regarding allowing RDAEF administration of local anesthesia and nitrous oxide. Given the lack of Board staff resources and complexity of these issues, the Council established a two-member working group to discuss the specific issues to be studied, create relevant survey questions, and return to the Council with a list of the specific issues to be studied and survey questions.

#### Update

The two-member working group consisting of Jerri Fowler, CDA, RDAEF, OA, Council Chair, and Traci Reed-Espinoza, RDAEF, Council Vice Chair, met and developed survey questions, to be given to RDAEFs and dentists, separately, for the Council's consideration and feedback. The Working Group's memo to the Council describing the survey questions is attached.

The Department of Consumer Affairs' (DCA) Office of Professional Examination Services (OPES) has reviewed the survey questions and has offered the following recommendations for the Council's consideration:

- <u>Recommendation 1:</u> The Council initially administer two separate surveys, one to RDAEFs who meet the qualifications for licensure established in 2010 and the other administered to dentists who supervise RDAEFs. If the survey is also sent to dental associates and RDHs, OPES recommends that these be designed as separate surveys as well; however, the Council may want to first obtain information from RDAEFs and dentists and then make a determination as to whether additional information from other dental professions is indicated.
- Recommendation 2: The survey repeats questions by type of procedures performed by RDAEFs in practice. Survey length and repetition of questions can impact response rates; therefore, OPES recommends gathering data across procedures performed by RDAEFs under their scope of practice. However, if the Council would like the information broken out, OPES is happy to assist.
- Recommendation 3: OPES is willing to assist with revising the wording and scales for some of the survey questions to more accurately capture information. In addition, OPES is willing to assist with developing additional questions to include in the survey.

## Background:

On August 25, 2018, the EF Association launched a survey on Survey Monkey requesting information on EF2 functions being performed in practice and included questions regarding local anesthesia. It was closed on September 28, 2018. At that time there were 705 current licensed RDAEF2s in California. They had 275 of the 705 RDAEF2s respond to the survey yielding a 39% response rate. A summary of the results of this survey were:

- There was a total of 53% of RDAEFs who needed additional anesthesia for direct restorations and 71% of the RDAEFs needed additional anesthesia for packing cord and taking final impressions.
- 94.53% of the RDAEFs surveyed indicated that their employing dentist would like them to be able to administer local anesthesia.

OPES reviewed the results of the survey and believed it was informative regarding the perspective of one group of RDAEFs. However, even though the proposal addressed administration of both local anesthesia and nitrous oxide, the survey only focused on local anesthesia. OPES was also concerned that the RDAEFs were aware of the purpose of the survey, which may have influenced their responses.

During the November 18, 2021 Dental Assisting Council meeting, action was taken to appoint a two-member committee which included DAC members Jeri Fowler and Traci Reed Espinoza to discuss specific issues to be studied and create relevant survey questions to report back to the council in January 2022.

#### Rationale:

The topic of determining if Local Anesthesia and Nitrous Oxide should become an allowable duty of the RDAEF2 is a two-step process:

Step 1: Should we? This can be determined by gathering relevant data via a non-biased survey.

Step 2: If yes to step 1, how do we proceed and implement?

Patient care and well-being is the #1 concern of the Dental Board of California and

patient comfort and happiness is every dental practitioner's goal. So, questions that need to be addressed that relate to the administration of additional local anesthesia and nitrous oxide are:

- How long does the patient need to wait for additional local anesthesia and/or nitrous oxide to be administered?
- Procedure efficiency how much extra time is added to the procedure by waiting for local anesthesia and/or nitrous oxide to be administered and take effect?

<u>Painful dental procedures and long appointments are practice killers and can cause</u> dental phobias in patients.

The survey should be taken separately by RDAEFs and their employing Dentists and/or Hygienists who are responsible for administering additional local anesthesia and nitrous oxide to their patients. This will allow more validity to the survey results by cross referencing the data results between Dentists/Hygienists providing the anesthesia with the RDAEF data results.

### Proposal:

All practices that utilize RDAEFs should be given access to this survey. Invitation emails can be sent to dentists requesting participation if they work with RDAEFs in their practice and encouraging all staff who provide local anesthesia and nitrous oxide in their practice to participate as well. Invitation emails will be sent to RDAEFs encouraging their participation and all others in their practice who provide local anesthesia and nitrous oxide.

This survey should be taken separately by RDAEFs and their employing Dentists and/or Hygienists who are responsible for administering additional local anesthesia and nitrous oxide to their patients.
