SB 501 Anesthesia and Sedation

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Department of Consumer Affairs, Dental Board of California (hereinafter "Board") will hold a public hearing on the proposed regulatory action to amend section 1017 of Article 4, section 1021 of Article 6 of Chapter 1, sections 1043, 1043.1, 1043.2, 1043.3, 1043.4, 1043.5, 1043.6, 1043.7, and 1043.8 of Article 5, sections 1044, 1044.1, 1044.2, 1044.3, and 1044.5 of Article 5.5 of Chapter 2, and section 1070.8 of Article 2 of Chapter 3, and add section 1043.8.1 of Article 5 and sections 1043.9, 1043.9.1, 1043.9.2 of Article 5.1 of Chapter 2, and repeal section 1044.4 of Article 5.5 of Chapter 2 of Division 10 of Title 16 of the California Code of Regulations, related to anesthesia and sedation.
